The Hudson Fire Department presented an amended burning by-law to repeal their existing burning by-law. The purpose of the amended burning by-law is to allow for burning of windrows and piles throughout the summer given proper conditions, as well as better plan and control how permits for such burning will be issued by the Fire Department. At the moment, office staff are issuing burning permits, however under the new burning by-law the Fire Department will inspect windrows and piles prior to issuing a permit. The Fire Department believes this amended by-law will reduce smoke hazards created by farmers by spreading out the time piles and windrows are burned, rather than burning them all at once during the fall.
