a. Shawn Morrow, Fire Chief RE: New Fire Hall

The Hudson Fire Department expressed their concerns regarding the future of the existing fire hall. The fire hall does not have the proper depth to fit newer and the more standard fire trucks in the existing bays. This makes it difficult to locate replacements. When replacements are found, they are costly.

The Clerk-Treasurer informed council recent construction costs for new fire halls were estimated at \$190/square foot, not including costs to service and furnish. This estimated cost per square foot was before the recent increase in building materials. It was recommended for a more

relevant cost per square foot for the township's district, the township refer to the City of Temiskaming Shore's RS-RFP-002-2021 scheduled to close on April 15th. This request for proposal is for the construction of a new 8,000 square foot, 3 bay facility.

The fire department believes a 5,000 square foot facility would accommodate their requirements. Based on an estimated construction cost of \$190/square feet, total costs would be \$950,000 before HST and costs to service and furnish.

Council directed municipal staff to create a new reserve for the construction of a new fire hall in 2021's budget, which is to be presented to council for their approval.

Parts have been ordered for the grader and it has also been having shifting problems but has since been resolved. On March 28th, we received approximately 9 inches of snow.

b. Fire's Department Report

The Fire Chief reports that the department responded to one Carbon Monoxide call this month and it was due to faulty equipment. All trucks have had a safety and have been serviced. The Fire Department currently has 18 members and an average of 75% attendance at all meetings.
