The Road Superintendent reported that shoulders have been cut off the road with the grader. Grader and trucks are ready for summer. Old pit had the gate ripped down so a berm has been dug instead. Buried a trench at the dump and moved the recycling bins back. The side of the road gave out on Morrow Road by Pipeline Road. Surface treatment on Sawmill Road was ripped up by a known property owner's tracked machine. Council directed staff to issue the property owner the cost of repair. Summer tires were put on pickup. Graded Access Road and swept off the sides.

The Fire Chief reports that there were 2 fires during the month of April. The first call was at 1:40 am for a structure fire, but was found to be a false alarm. The second Fire call was a grass fire that was quickly extinguished due to a fast response by the members of the fire department. Whereas the Stronger, Fairer Ontario Act, 2017 enabled the Attorney General to enter into agreements with municipalities to transfer responsibility for certain prosecutions currently prosecuted by the Ministry's Criminal Law Division under Part III of the Provincial Offences Act (POA); and

Whereas the Ministry's effort to modernize POA prosecutions has been ongoing for over three years; and

Whereas the delay in implementing the transfer of responsibility of certain Part III POA prosecutions to municipalities has resulted in inefficiencies and additional costs; and

Whereas on November 19, 2019 the Director of Crown Operations North Region advised the City of Temiskaming Shores it was continuing its plan for a phased approach to transfer the responsibility of certain Part III prosecutions based on local site readiness and capacity to assume the responsibility; and

Whereas the City of Temiskaming Shores is responsible for the administration of POA matters in the District of Timiskaming with the exception of prosecutions under Part III of the Provincial Offences Act; and
