6. Reports from Staff & Others

a. Road's Department Report

The Road's Superintendent reports that they have prepared the cold mix for the coming winter season. Summer equipment was cleaned and stored. Salt was delivered and sand will be done by end of October or by

November 13th. Grading was done when weather permitted. Hillview Road needed attention and was graded on October 6th after the rainfall. It was also graded again on October 11th. Gravel at the turnarounds needed to be smoothed out from ATV's doing donuts. The Western Star went for its annual safety and a few repairs were necessary. The Kenworth is in Mattawa for repairs, and it has also been undercoated. The Superintendent also reports that culverts were repaired and marked. They have also pushed wood piles and the trench at the dump.

b. Fire Department Report

Acting Fire Chief Jason Morrow notified council that Shawn Morrow is willing to be the Fire Chief once again. Jason Morrow presented to council some additional compensation requests for members of the fire department including the Fire Chief, Deputy Fire Chief and volunteer members as outlined in the Memo to council. He requested an increase to the points budget for 2023 and a cell phone allowance for the Fire Chief and Deputy Fire Chief positions of \$75/month. Attendance for calls and meetings is consistently very good among all members.

vi. Reports from Council and Staff

-TMA Update - Reeve Craig provided an update from TMA discussions. There is some funding for Northern Ontario Fire departments, but not for trucks. There are supposed to be further incentives for housing in Northern Ontario, however due to the makeup, much of this incentive will be directed further south of our area. Issues with the trucking industry and driver training were discussed. Mayor in Elk Lake has been working with Fisets to see if

older fire trucks can continue to be certified. Nothing has developed on that yet. Ongoing discussions continue about Medieval Villages.

- Councillor McLean, notified Council she reached out to the City of Temiskaming Shores regarding the landfill. The city shared their closing costs and costs to open the new landfill which was in the millions. The City has wells which need to be monitored, adding a large amount of cost. Councillor McLean suggested that an engineer's report on the landfill would provide Council with information about remaining life of the landfill and options when the landfill needs to be closed. Council asked whether stacking the garbage was permitted and what the current agreement permits. Municipal staff will look into these documents.
- Municipal staff provided an update on online voting. Quotes for the 2026 election are unavailable at this time. Staff have made some initial contacts to inquire as to what is involved, and when an RFP should be sent out for quote. Most municipalities first engage in the fall of year before the election.
- There was a brief discussion in regards to posting the agenda and/or council package on the municipal website. Council directed staff to begin posting the agendas for the upcoming meetings on the municipal website.
